
The AfterLife™ service is an agreement that will serve to comply your wishes in this step of your life.

- Since we will be your legal contact, in case of emergency, we can assist you in any city inside the Mexican territory

## The funeral process



- We are committed to contract the funeral procedures (Burial and/or Cremation and/or shipment of ashes or remains to the place indicated by you)
- We will carry out the procedures before the Civil Registry and any other institution and relevant dependency after your decease.
- We will carry out the procedures needed before the Consulate of your country of origin, in the order to obtain your "Death Certificate".
- We are obliged to contact your relatives, heirs or legatees, immediately after your decease.
- There are no border restrictions in case you want your remains to go to the United States of America.
